IV. Concrete/Railings/Asphalt

- a) Vice President Smith reported that a 5 Year Project is underway for asphalting all courts with (2) two being done (Arlington and Washington). The goal is to do (2) two or (3) three courts per year until all are completed.
- b) V. P. Smith states the driveways in most disrepair will be the first to be done this coming spring/summer.
- c) A number of courts will be striped and repainted this year as well.
- d) After the winter melt the sidewalks will be assessed to see damage done to concrete.

V. Clubhouse/Pool

- a) Jay Patel has created a questionnaire to be distributed to residents concerning the Pool. This survey's goal is to get overall view of what homeowners want regarding pool being managed by an outside pool management company or by CCHA themselves. Several bids are being considered currently.
- b) Board will take into account the questionnaire results and vote on pool contract for the 2014 Pool Season. Factors taken into account will be budget, lifeguards, ins. liability and treatment of water.
